Judicial Review Principles

“David, can we JR this?”

Principles

- The challenge must be on a point of law, not because you disagree with the merits.
- Broadly, a decision (or lack of decision) can be challenged in 4 scenarios:
 - Unlawful
 - Wednesbury Unreasonable
 - Procedurally Unfair
 - Breach of Human Rights

Unlawfulness

- GCHQ Case [1985] AC 374 at 410:
- *“The decision maker must understand correctly the law... and give effect to it”*
- Must comply with a duty:
 - Statutory Duties (e.g – Equality Act 2010, Care Act 2014)
 - Due Regard Duties (PSED)
- Must act within powers (*Anisminic* [1969] 2 AC 147)
- Must consider relevant matters and not irrelevant matters (*Fewings* [1995] 1 WLR 1037 at 1049)
- Must adhere to published policy unless good reason otherwise (*Munjaz* [2006] 2 AC 148)

Wednesbury Unreasonable

- Traditional: *Wednesbury* [1948] 1 KB 223:
- “so *unreasonable that no reasonable authority could ever have come to it.*”
- Modern: *R (Law Society) v Lord Chancellor* [2018] EWHC 2094 (Admin) at § 99:
- “*whether the decision is outside the range of reasonable decisions open to the decision-maker.*” or
- “*there is a demonstrable flaw in the reasoning which led to it.*”

Procedurally Unfair

- The common law imposes minimum standards of fairness (*Citizens UK* [2018] EWCA Civ 1812)
- Duty of Enquiry (*Tameside* [1976] UKHL 6)
- Breach of legitimate expectation (*Alansi* [2014] PTSR 948 at 962-963)
- Fettering Discretion (*British Oxygen* [1971] AC 610 at 625)
- Inadequate Reasoning (*Hasan* [2009] 3 All ER 539 at [19] and *South Buckinghamshire* [2004] 1 WLR 1953)
- Disproportionate outcome (*Khatun* [2005] QB 37)
- Delay (FH [2007] EWHC 1571 (Admin))
- Consultation (*Moseley* [2014] UKSC 56 at [23] and *Eveleigh* [2023] EWCA Civ 810 at [83-84])

Breach of Human Rights

- Section 6 Human Rights Act 1998 – Duty to comply with the ECHR.
- *“High-intensity review” (A v Chief Constable of Kent [2013] EWCA Civ 1706 at [36])*
- Commonly pleaded:
 - Article 3 (freedom from inhuman and degrading treatment)
 - Article 5 (right to liberty)
 - Article 6 (right to fair trial)
 - Article 8 (right to private and family life)


Practical Issues and Procedure

Pre-action Considerations

- Duty of Inquiry - CPR 54A PD para 4.1(1) & Admin Court Guide para 7.4
- Letter of Initial Observation – duty of candour, Admin Court Guide para 7.5
- Part 18 Request – Exceptional; *JZ* [2022] EWHC 1708 (Admin), [26]-[28].
- Judicial Review Pre-Action Protocol
 - Must send a letter before claim (template annexed to protocol)
 - Def will generally have 14 days to respond (but can be sooner)
 - Does not stop the clock, but a prior agreement not to take a time point can be relevant to the exercise of Court's discretion (Admin Court Guide para 6.4.2.1 & JR PAP)
- LAA Funding (legal help, investigative, full rep)
 - Pre-action – Legal Help
 - Issuing Claim – Full Representation

Timing

- The claim must be filed (a) promptly, and (b) in any event not later than 3 months after the grounds to make the claim first arose (CPR 54.5(1)) – subject to exceptions...
- Clock starts when the decision is made, not when you know about it (*Presvac Engineering* [1992] 4 Admin LR 121), unless it is a policy, in which case it is when first affected by policy (*Badmus* [2020] EWCA Civ 657).
- Permission can be refused for delay – s.31(6) SCA 1981
- Can extend time, per CPR 3.1(2), but see QR (Pakistan) [2018] EWCA Civ 1413 at § 45 and Denton
- TIP: You can't get started quickly enough
- TIP: If you want interim relief or expedition, get started now!

Jurisdiction

A Local Court for Local People

Venue

- Closest connection to Claimant (CPR PD 54C)
- Remember for Western Circuit cases, the case must be filed in Cardiff ACO and will be heard on Western Circuit, probably Bristol (Admin Court Guide 2023, para 7.7)
- It will be transferred if wrong - Fordham J, *Ellis* [2022] EWHC 1263 (Admin) & *Forrt* [2022] EWHC 152 (Admin)
